Notice of Public Comment Period for Draft Public Participation Plan (PPP)

The Fredericksburg Area Metropolitan Planning Organization (FAMPO) has released for public review the Draft Public Participation Plan (PPP) for a 45-day public review period as required by the United States Department of Transportation's metropolitan planning regulations 23 Code of Federal Regulations Part 450. The purpose of this draft Public Participation Plan (PPP) is to not only **continue** to serve as a guide

for FAMPO staff in the development of public outreach strategies used in the transportation planning process, but to also place a stronger emphasis in reaching our region's Title VI community which includes older adults, persons who are limited English proficient, persons with disabilities, ethnic groups and **low income** populations. Effective transportation planning recognizes the critical link between transportation and other societal goals.

A public comment period will begin on Monday, September 24, 2012 and will end on Monday, November 19, 2012.

Written comments will be accepted until 2:00 p.m. on November 19, 2012. Spoken comments will be accepted during the public hearing scheduled to begin no earlier than 7:10 p.m. during the Policy Committee meeting on November 19, 2012. The public hearing will be held at the GWRC/FAMPO office located on **406 Princess Anne Street** in Fredericksburg, Virginia.
