1. **Call FAMPO Policy Committee Meeting to Order – Chairman Kelly** called the meeting to order at **7:15 p.m.**

The motion to approve the agenda by Ms. Maurer seconded by Mr. McLaughlin, with all concurring.
4. **Public Involvement - Stafford [County], Aquia resident, Mr. David Star, 76 Olde Concord Rd, Stafford VA 22554:** Written comments, “I would like to address the Board on the need to have an alternate route through the region north and south besides I-95 and Rt1/301. I envision a I-295 like road from Spotsylvania *sic* County to Stafford. Either east or west of the current bridges. I know that the lease with Transurban may have to be re-worked to allow a competing road, unless we use 301 as an alternative road north and turn it into a limited access hwy.”
