Gold = Additional projects from extra SMART SCALE Funding and/or FAMPO CMAQ/RSTP
Yellow = Close to being selected
Red = Regional I-95 projects which were not close to being selected.
White = District Grant projects that were not close to being selected.

Summary Points

- 1 Category B weighting would have led to 19 out of 21 FAMPO projects increasing in State Rank and 2 decreasing.
- 2 Category B weighting would have resulted in 13 out of 21 FAMPO projects increasing in District Rank, 6 decreasing, and 2 remaining unchanged.
- 3 I-95 Projects would have scored better in Category B than in Category A.
