- a. State Fall Transportation Meeting Summary, November 12, 2019 Mr. Paul Agnello
  - The I-495/American Legion Bridge between Maryland and Virginia will be widened with Express lanes
  - The Express Lanes for I-395 opened November 17, 2019
  - i. Letter to Secretary of Transportation I-95 Study Input
    - Potential Improvements: State was receptive to numbers 1 and 4
      - o 1) A fourth southbound (SB) lane from Exit 130 to Exit 126
      - 4) A commuter bus from Spotsylvania Route 3 corridor to NOVA/DC



- o 2) and 5) under consideration (see Agenda Packet)
- o 3), 6) and 7) will not be included in the study; not significant improvements to I-95
- Number 8 is under consideration by the state: express lane extension further from Massaponax with bi-directional option from the Study
- State was supportive of SMART SCALE move from Category A to B
- ii. Letter to Secretary of Transportation: Exit 133 Pedestrian Improvements
  - The state was receptive to raise the budget for necessary improvements
- ix Virginia Department of Transportation (VDOT) Response regarding FAMPO Traffic Volume Question
  - The State presentation included data for current, not future, traffic; such data will not be gathered due to Study timeline. Staff recommends no further action at this time
  - The presentation was postponed, perhaps for some time in December
