FAMPO RESOLUTION 20-46 DRAFT

**TRANSFERRING AVAILABLE SURFACE TRANSPORTATION BLOCK GRANT
(STBG)/REGIONAL SURFACE TRANSPORTATION PROGRAM (RSTP) FUNDS**

WHEREAS, FAMPO receives yearly allocation of STBG/RSTP and CMAQ funding with a state match;
and

WHEREAS, FAMPO has worked cooperatively with the Technical Advisory Committee to identify
CMAQ & RSTP funding available and has developed four proposed allocation transfers; and

WHEREAS, these four allocation transfers will aid in providing \$525,000 to Route 1 and Telegraph
Road/Woodstock Lane, as outlined in Attachments 1 and 2.

NOW, THEREFORE, BE IT RESOLVED that the Fredericksburg Area Metropolitan Planning
Organization hereby approves the four allocation transfers shown in Attachment 1 and in the CMAQ &
RSTP matrix in Attachment 2.
