The Fredericksburg Area Metropolitan Planning Organization (FAMPO) is the regional government body that makes transportation funding decisions, studies transportation problems, and develops long-range transportation plans for the Fredericksburg region which includes the City of Fredericksburg, Stafford County, and Spotsylvania County.
