## FAMPO RESOLUTION 21-17

**AMENDING THE FY21-24 TIP TO APPROVE THE RW, PE, AND CN PHASES FOR UPC 110914, #SMART18 – I-95 EXIT 126, RTE 1 SB ONTO SOUTHPOINT PKWY; UPC 110932, #SMART18 – TWIN LAKE-KENSINGTON BIKE/PED CONNECTOR; AND UPC 109474, #HB2.FY17 – NEW COMMUTER PARKING LOT RTE 1 AT COMMONWEALTH DR**

**WHEREAS**, the Fiscal Year (FY) 2021-2024 Transportation Improvement Program (TIP) was adopted by FAMPO on May 18, 2020; and

**WHEREAS**, VDOT has requested that FAMPO add and adjust funding in order to advance three projects in the TIP – UPCs 110914, 109474, and 110932; and

**WHEREAS**, UPC 110914 is a Smart Scale Round 2 project in Spotsylvania County at I-95 Exit 126, UPC 109474 is a Smart Scale Round 1 commuter parking lot at Route 1 and Commonwealth Drive in Spotsylvania County, and UPC 110932 is a Smart Scale Round 2 bicycle and pedestrian connector in the City of Fredericksburg; and

**WHEREAS**, additional project and funding information for each UPC can be found in the supporting documentation with this resolution; and

**WHEREAS**, UPCs 110914 and 109474 are considered regionally significant and were included as such in the FY21-24 TIP and 2045 Long Range Transportation Plan (LRTP) that received a conformity finding from FHWA dated May 2020. This amendment only changes the project funding and would not significantly change how it was modeled in the analysis (i.e., project termini, number of lanes, analysis year, etc.). Since this project is already included in a conforming TIP and LRTP, a new conformity determination is not needed; and

**WHEREAS**, UPC 110932 is not considered regionally significant and as such, a new conformity determination is not needed.

**NOW, THEREFORE, BE IT RESOLVED** that the Fredericksburg Area Metropolitan Planning Organization Policy Committee hereby amends the FY2021-2024 TIP to reflect the changes in funding for UPC 110914, UPC 110932, and UPC 109474.
