## FAMPO RESOLUTION 21-16

### APPROVING THE FISCAL YEARS 2021-2024 TRANSPORTATION IMPROVEMENT PROGRAM ROLLOVER AMENDMENT

**WHEREAS**, FAMPO is responsible for ensuring that the federally required metropolitan transportation planning process is carried out in the Fredericksburg region; and

**WHEREAS**, the Fiscal Years (FY) 2021-2024 Statewide Transportation Improvement Program (STIP) was approved by Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) on October 1<sup>st</sup>, 2020; and

**WHEREAS**, due to the large number of rollover projects, Virginia Department of Transportation (VDOT) has requested that FAMPO update its metropolitan TIP to reflect actions already approved by the Policy Committee between October 2019 and September 2020 so that the TIP and STIP remain in sync, in accordance with federal regulations; and

**WHEREAS**, UPCs 105535, 110913, 110914, 110932, 111753, 116651, 116652, 116653, 116654, 116655, 116656, 116657, 116658, 116659, 116660, 116661, 111883, and 111884 (attached) are included in the rollover amendment in order to remain current with the STIP; and

**WHEREAS**, the UPCs mentioned above have been amended and approved in the FY18-21 TIP; this rollover amendment formalizes these adjustments for the FY21-24 TIP.

**NOW, THEREFORE, BE IT RESOLVED** that the Fredericksburg Area Metropolitan Planning Organization hereby approves the FY21-24 TIP rollover amendment for submission to VDOT for incorporation into the STIP by FHWA and FTA.
