UPC/STIP ID affected:	RACS001
Revision purpose and details:	This STIP ID relates to Paratransit Vehicles. In FY22, \$260,000 will be available for this project via FTA 5310 funds. The Americans with Disabilities Act (ADA) requires public transit systems to provide “paratransit” services. Paratransit is for people with disabilities who cannot use the “fixed route” provided by the bus or rail service. Paratransit must provide service that is comparable to the service provided to the general public who uses the fixed route system.
Air Quality Conformity Requirement:	STIP ID RACS001, Paratransit Vehicles, is considered exempt from conformity under the following provision contained in section 93.126 of the conformity rule; “Purchase of new buses and rail cars to replace existing vehicles or for minor expansions of the fleet.”
MPO requirement:	Amendment requiring board approval and public comment period

**APPROVING THE FISCAL YEARS 2021-2024 TRANSPORTATION IMPROVEMENT PROGRAM (TIP) AMENDMENT TO ADD PARATRANSIT VEHICLES FOR THE RAPPAHANNOCK AREA COMMUNITY SERVICES BOARD**

**WHEREAS**, the Fiscal Years (FY) 2021-2024 TIP was adopted by FAMPO on May 18, 2020 and subsequently implemented on October 1, 2020; and

**WHEREAS**, the Virginia Department of Rail and Public Transportation (DRPT) has requested that FAMPO add STIP ID RACS001 related to the purchase of Paratransit Vehicles for the Rappahannock Area Community Services Board (RACSB); and


**WHEREAS**, RACS001 is considered exempt from air quality conformity under the following provisions contained in section 93.126 of the conformity rule: "Purchase of new buses or rail cars to replace existing vehicles or for minor expansions of the fleet."

**WHEREAS**, this new project triggers a TIP amendment; and

**WHEREAS**, a 30-day public comment period and public hearing have been held and no adverse comments were received.

**NOW, THEREFORE, BE IT RESOLVED** that the Fredericksburg Area Metropolitan Planning Organization Policy Committee approves the addition of RACS001 to the FY21-24 TIP.
