**1. Call to Order**

The meeting was called to order by Chair Rowe at 6:00 p.m.

**2. Roll Call**

Mr. Ridout conducted roll call and a quorum was present.

**3. Approval of the October 12, 2022 Citizens Transportation Advisory Committee (CTAC) Agenda (ACTION ITEM)**

Motion was made to approve the agenda as presented.

Motion passed with unanimous consent.

**4. Approval of September 14, 2022 CTAC Meeting Minutes (ACTION ITEM)**

Motion was made to approve the minutes as presented.

**5. Public Comment**

Ms. Leeds asked if past comments provided to CTAC regarding light rail and electric trolley systems had been considered; and also advised attendees that she is seeking support from CTAC on a request to State Senator Bryce Reeves to promulgate legislation requiring that Virginia transportation projects include audible pedestrian signals and contiguous sidewalks as part of their project scope.

**6. New Business and Action Items**

**a. Election of the Vice-Chair**

Chair Rowe asked for nominations of Vice-Chair, and clarified those eligible by the CTAC by-laws include CTAC appointees from either Spotsylvania or Stafford (since the Chair is from City of Fredericksburg).

Motion was made by Mr. Farley to nominate Neil Holloran for Vice-Chair. Mr. Holloran explained that his familial obligations with four children makes it difficult for him to accept the nomination.

Motion was made to nominate Mr. Kwatnoski for CTAC Vice-Chair.

Motion: Mr. Holloran; Second: Ms. Palbalkar

Motion passed with unanimous consent.

- b. Endorse Resolution 23-06 Approving an Amendment to the FY 21 – 24 Transportation Improvement Program to Add UPC T11606: Fredericksburg Station Rehabilitation

Mr. Ridout explained the project scope: lengthen existing platforms, and improve signage, sidewalks, lighting, and painting of canopies, with a total cost of \$9.6 Million. Mr. Farley observed that the platforms are not level with passenger train floor height in order to accommodate freight train rail cars. Questions and discussion among CTAC members shifted to the future high speed rail proposal.

Motion to approve Resolution 23-06.

Motion passed with unanimous consent.

A newly appointed CTAC member, Mr. Brett Bearce, was introduced and shared his interest and experience with attendees. Mr. McLaughlin, who was attending remotely, advised attendees that the microphone system was unusually weak, making it difficult to hear discussions and participate. In-person speakers need to speak directly toward the speakers and more loudly. Mr. Farley, who was reading the captioning, noted that the captioner could not hear attendees that spoke softly and were further from one of the three microphones. Mr. McLaughlin also briefed attendees that there is a future third track, and a new rail station to be constructed closer to the river. Mr. McLaughlin has concerns with the 2075 Vision plan, but made known his sincere desire to make CTAC and FAMPO successful. Chair Rowe requested an update from VDOT on the northbound I-95 Variable Speed Limit project.
