

CMAQ/RSTP Program Project Scores and Funding

Technical Committee

Background

- State released FY20-25 budgets
 - net decrease of \$2,382
- Need to allocate FY20-25 CMAQ/RSTP funding by late April
 - Request for FAMPO approval on April 15th

Call For Projects

- Call for projects: February 4th to 26th
 - 7 new project submitted with a request cost of about \$18.6 Million
- Rescore existing projects that are not fully funded/on track to be fully funded
 - Fully funded FY 19-24 SYIP projects, Smart Scale projects, and I-95 NB River Crossing project will not be rescored
 - 4 Rescored projects with a request cost of about \$31.9 Million:
 - Enon Rd @ Rte 1 intersection improvements
 - Gateway Blvd extended
 - Mine Rd Widening
 - Leased parking spaces
- Limited funding available of about \$12.6 Million competing for \$50.6 Million total
 - No guarantee of funding for new projects
 - Some existing projects with partial funding could be defunded
 - Allocations for FY-20 to FY-26, but most funding in out years: FY 24 to FY-26
