A RESOLUTION OF THE FREDERICKSBURG AREA METROPOLITAN PLANNING ORGANIZATION AMENDING THE FY2018-2021 TRANSPORTATION IMPROVEMENT PROGRAM FOR UPC 13558


WHEREAS, the FY2018-21 Transportation Improvement Program (TIP) was adopted by FAMPO on May 15, 2017; and

WHEREAS, as part of the TIP rollover process, the Virginia Department of Transportation (VDOT) has requested that FAMPO amend its TIP to include changes to UPC 13558; and

WHEREAS, this TIP amendment involves changes in GARVEE bond funding for the project, as shown in the attachment to this Resolution;

NOW, THEREFORE, BE IT RESOLVED THAT THE FY2018-21 TIP IS HEREBY AMENDED TO UPDATE FUNDING FOR UPC 13558, AS SHOWN IN THE ATTACHMENT TO THIS RESOLUTION.
