Project Overview

The Virginia Secretary of Transportation's Office of Intermodal Planning and Investment (OIPI), in cooperation with the Virginia Department of Transportation (VDOT) and the Virginia Department of Rail and Public Transportation (DRPT), is developing a Corridor Improvement Plan at the request of both Senate and House of Delegate resolutions (SJR 276 and HJR 581) passed by the 2019 General Assembly. VDOT has initiated the study, which will result in an Interstate 95 Corridor Improvement Plan (Plan) that is to:

- Designate specific segments of the Interstate 95 corridor between Exit 118 and the Springfield Interchange for improvement. Study area extended to include I-95 through the Commonwealth of Virginia
- Identify incident management strategies corridor-wide
- Determine potential solutions to address region-specific needs along this Interstate 95 corridor

- Identify funding and financing options for targeted improvements
- Ensure that each segment's total long-term benefit is proportional to the funds allocated to that segment in relation to the total corridor

There are three phases of the study:

1. Problem identification
2. Potential solutions (current phase)
3. Prioritized/recommended projects

Current status of the study: Following the July public information meetings, the study team used a data-driven approach to develop potential infrastructure, transit, and operations solutions to solve safety, congestions, and resiliency issues in the I-95 corridor. The team reviewed responses from more than 3,000 commenters in addition to performance measure data, crash reports, traffic volumes, geometry, and other available data to develop the potential solutions presented at this set of meetings. Potential solutions are tied to existing critical issues in the corridor.

Public Meeting

A third set of meetings will be held later in the fall to outline the recommended improvements for the I-95 corridor based on the study.
