A RESOLUTION OF THE FREDERICKSBURG AREA METROPOLITAN PLANNING ORGANIZATION AMENDING THE FY2018-2021 TRANSPORTATION IMPROVEMENT PROGRAM TO UPDATE THE CHATHAM BRIDGE REHABILITATION PROJECT

WHEREAS, the FY2018-21 Transportation Improvement Program (TIP) was adopted by FAMPO on May 15, 2017; and

WHEREAS, the Virginia Department of Transportation (VDOT) has requested that FAMPO amend its TIP to update UPC 105535, the Chatham Bridge Rehabilitation Project; and

WHEREAS, this TIP amendment will allow VDOT to expedite the schedule for the right-of-way and construction phases of the project;

NOW, THEREFORE, BE IT RESOLVED THAT THE FY2018-2021 TIP IS HEREBY AMENDED TO UPDATE THE CHATHAM BRIDGE REHABILITATION PROJECT, AS SHOWN IN THE ATTACHMENT TO THIS RESOLUTION.
