FAMPO RESOLUTION 19-13

AMENDING THE FISCAL YEARS 2018-2021 TRANSPORTATION IMPROVEMENT PROGRAM TO UPDATE THE MUDD TAVERN ROAD WIDENING PROJECT

WHEREAS, the Fiscal Years (FY) 2018-2021 Transportation Improvement Program (TIP) was adopted by FAMPO on May 15, 2017; and

WHEREAS, the Virginia Department of Transportation (VDOT) has requested that FAMPO amend its TIP to update UPC 105464, the Mudd Tavern Road Widening Project; and

WHEREAS, this TIP amendment will allow VDOT to begin the right-of-way and construction phases for the Mudd Tavern Road Widening Project;

NOW, THEREFORE, BE IT RESOLVED that the Fredericksburg Area Metropolitan Planning Organization hereby amends the FY2018-2021 TIP to update the Mudd Tavern Road Widening Project, as shown in the attachment to this resolution.
