

FAMPO RESOLUTION 20-02

AMENDING THE FISCAL YEARS 2018-2021 TRANSPORTATION IMPROVEMENT PROGRAM TO APPROVE THE RIGHT OF WAY (RW) AND CONSTRUCTION (CN) PHASES FOR UPC 105510: I-95 NORTHBOUND RAPPAHANNOCK RIVER CROSSING PROJECT

WHEREAS, the Fiscal Years (FY) 2018-2021 Transportation Improvement Program (TIP) was adopted by FAMPO on May 15, 2017; and

WHEREAS, VDOT has requested that FAMPO add \$127,000,000 in FY-21 funding for the RW and CN phases for UPC 105510: I-95 Rappahannock River Crossing – Northbound to help advance the project with planned funding details available on the attached MPO TIP report sheet; and

WHEREAS, the I-95 NB Rappahannock River Crossing project is an important regionally significant project that is critical to alleviating traffic congestion and improving mobility in the I-95 corridor; and;

NOW, THEREFORE, BE IT RESOLVED that the Fredericksburg Area Metropolitan Planning Organization hereby amends the FY2018-2021 TIP to approve \$127,000,000 in FY-21 funding for the RW and CN phases for UPC 105510: I-95 Rappahannock River Crossing – Northbound as shown on the attached MPO TIP report sheet
